1 P R O C E E D I N G S

2 ROLL CALL HEARING

3 CHAIRPERSON FLETCHER: Will the parties  
4 in the matter of 1905 please come forward? The  
5 parties in the matter of 1905. This is case #16-  
6 PRO-00037 Bouche LLC, trading as 1905. 1905 9th  
7 Street Northwest, license #ABRA-077350. This is  
8 Retailer class CR, license renewal. The protest  
9 issues are adverse impact on peace, order and  
10 quiet. My name is Laverne Fletcher, I'm  
11 conducting the Roll Call Hearing as the Board's  
12 agent pursuant to D.C. Official Code 1601.2  
13 1601.2. Present on behalf of 1905?

14 MR. DUNDAS-LUCCA: Anthony Dundas-Lucca.  
15 Anthony, A-N-T-H-O-N-Y. Last name is D as in  
16 David, U, N as in Nancy, D as in David, A, S as  
17 in Sam, hyphen, L-U-C-C-A.

18 CHAIRPERSON FLETCHER: Thank you very  
19 much. Now how do you pronounce the last name?

20 MR. DUNDAS-LUCCA: Dundas Lucca.

21 CHAIRPERSON FLETCHER: Just like it's  
22 spelled. Mr. Dundas-Lucca, are you writing your

1 contact information on that sheet already?

2 MR. DUNDAS-LUCCA: Yes.

3 CHAIRPERSON FLETCHER: Thank you.

4 Present on behalf of ANC 1B?

5 MS. SULLIVAN: Commissioner Ellen  
6 Sullivan. The establishment is in my single  
7 member district.

8 CHAIRPERSON FLETCHER: Thank you Ms.  
9 Sullivan. Ms. Sullivan would you spell your name  
10 for the record please?

11 MS. SULLIVAN: E-L-L-E-N, and Sullivan is  
12 S-U-L-L-I-V-A-N.

13 CHAIRPERSON FLETCHER: Thank you very  
14 much. ANC 1B does have standing as a protestant.  
15 We need to set a date for a mediation and status  
16 hearing and protest hearing. I'll give you the  
17 date of the status and protest hearing first.  
18 The status hearing is set for July 13 at 9:30  
19 a.m., July 13 at 9:30. The protest hearing is  
20 set for August the 10th at 4:30, that's August 10  
21 at 4:30 p.m.

22 MS. SULLIVAN: Is it possible, I don't

1 expect that we would need to have a protest  
2 hearing, in fact I believe we will hopefully have  
3 this figured out later this week but is it  
4 possible to set the time of the protest hearing  
5 earlier in the day? For the purpose of the Roll  
6 Call Hearing that's the time I have to give you  
7 because that's the time I was given; however, you  
8 may petition the Board through Martha Jenkins.

9 MS. SULLIVAN: Okay.

10 CHAIRPERSON FLETCHER: Martha is M-A-R-T-  
11 H-A, J-E-N-K-I-N-S. You may petition the Board  
12 through Martha to change that time.

13 MS. SULLIVAN: Okay.

14 CHAIRPERSON FLETCHER: And if the Board  
15 has an earlier slot available in their calendar  
16 then she will let you know. So, otherwise that's  
17 the date but you know what to do to change it.

18 MS. SULLIVAN: Okay, and if -- I don't  
19 expect for us to need it; in fact, at this point  
20 I don't think we'll even need a mediation date if  
21 we can wait on setting that.

22 CHAIRPERSON FLETCHER: Well, what I'll do

1 in that case, Ms. Sullivan, I will set out the  
2 mediation close to the protest hearing.

3 MS. SULLIVAN: Perfect.

4 CHAIRPERSON FLETCHER: Well, I should be  
5 setting it close to the status hearing then.  
6 Because would you be expecting to have the status  
7 hearing?

8 MS. SULLIVAN: I'm hoping that we can  
9 have this -- we have our ANC monthly meeting this  
10 week --

11 CHAIRPERSON FLETCHER: Mm hmm.

12 MS. SULLIVAN: -- and I'm hoping that we  
13 can either have this resolved at this ANC meeting  
14 or at the one at the beginning of July, so Tony  
15 has been a good neighborhood, the ANC just needed  
16 time to clarify a few things --

17 CHAIRPERSON FLETCHER: Okay.

18 MS. SULLIVAN: -- so I fully expect for  
19 us to get this worked up quickly.

20 CHAIRPERSON FLETCHER: Well then, in that  
21 case, what I can do just for the record is set a  
22 mediation for July 12th.

1 MS. SULLIVAN: That sounds great.

2 CHAIRPERSON FLETCHER: I'll put it out as  
3 far as I can.

4 MS. SULLIVAN: Perfect, thank you, we  
5 appreciate you doing that.

6 CHAIRPERSON FLETCHER: And I'll just make  
7 it at 9:00 so we have something on a book, I'll  
8 make a note that it's probably not going to  
9 happen but I'll have it on there.

10 MS. SULLIVAN: Thank you, we appreciate  
11 that.

12 CHAIRPERSON FLETCHER: So I have  
13 mediation set for Tuesday July 12 at 9:00 in  
14 case it's necessary.

15 MS. SULLIVAN: Yes, ma'am.

16 CHAIRPERSON FLETCHER: Okay any  
17 questions? Okay, thanks for coming, Roll Call  
18 Hearing is concluded.
