**ORDER ON SETTLEMENT AGREEMENT**






Accordingly, it is this 24<sup>th</sup> day of September, 2014, **ORDERED** that:



2. Copies of this Order shall be sent to the Applicant and ANC 6E.



Pursuant to D.C. Official Code § 25-433, any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14<sup>th</sup> Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code 2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 500 Indiana Avenue, N.W., Washington, D.C. 20001. However, the timely filing of a Motion for Reconsideration pursuant to D.C. Official Code § 25-433, stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b).

Dear Chairperson Miller:

Regarding Beau Thai Shaw, LLC t/a Beau Thai, 1550 7th Street, NW, Retailer's Class CR License #ABRA-095815:

Advisory Neighborhood Commission 6E conducted a public meeting on Tuesday, September 2, 2014 at the Northwest One Library, 155 L Street, NW, to consider the above application.

At the Commission's meeting, duly noticed and with this case listed in the notice, with a quorum present (four out of seven Commissioners required to be in attendance to achieve a quorum), ANC 6E voted (5 in favor, 2 opposed, and no abstentions) to support the application for a Class C Restaurant ABC license for Beau Thai at 1550 7<sup>th</sup> Street, NW, subject to the provisions of the voluntary agreement signed by the applicant and the Commission, and that said support be communicated in writing to the Alcoholic Beverage Regulatory Administration and the Alcoholic Beverage Control Board.

In deliberating on this case, the Commission considered and determined the following:

- 1) This Establishment will be located in SMD 6E01.

- 2) The Commission supports the issuance of this license, subject to the conditions enumerated in the agreement signed by the applicant and the Commission.
- 3) The Establishment's hours of operation shall not exceed the following: Sunday-Thursday, 7:00 AM to 2:00 AM, and Friday-Saturday, 7:00 AM-3:00 AM, inclusive of holidays. The Establishment's hours of alcoholic beverage sales, service, and consumption shall not exceed the following: Sunday-Thursday, 8:00 AM-2:00 AM, and Friday-Saturday, 8:00 AM-3:00 PM, inclusive of holidays. This will not preclude the Establishment applying for the ability to serve alcohol during extended hours made possible by law during special events, such as presidential inaugurations and major sporting events.
- 4) The hours of operation for the sidewalk cafe shall not exceed the following: Sunday-Saturday, 7:00 AM-12:00AM, inclusive of holidays. The hours of alcoholic beverage sales, service and consumption for the Establishment's sidewalk café shall not exceed the following: Sunday-Saturday, 8:00 AM-12 AM, inclusive of holidays.
- 5) There will be no amplified or unamplified music of any kind in the sidewalk café.

For the reasons listed above, Advisory Neighborhood Commission 6E recommends that the Alcoholic Beverage Control Board approve the application and the Settlement Agreement between the Commission and the Licensee, thereby granting ANC 6E's recommendation the Great Weight provided for in the ANC statute.


**AGREEMENT BETWEEN  
BEAU THAI SHAW, LLC, T/A BEAU THAI  
AND ADVISORY NEIGHBORHOOD COMMISSION 6E**

This Agreement between Beau Thai Shaw, LLC t/a Beau Thai, hereinafter referred to as the "Applicant" or the "Establishment," and Advisory Neighborhood Commission 6E, hereinafter referred to as the "Commission," codifies the agreement between the parties. This Agreement shall be submitted for approval by the Commission at its September 2, 2014 meeting, when the Applicant shall seek the Commission's support for the issuance of a Retailer's Class "C" Restaurant license under License No. ABRA-095815 and is subject to approval by the District of Columbia Alcoholic Beverage Control Board (hereinafter referred to as the "Board"). The Establishment is located at 1550 7th Street, NW, Washington, DC 20001.

The parties agree to the following:

- 1) The Establishment's hours of operation shall not exceed the following: Sunday-Thursday, 7:00 AM to 2:00 AM, and Friday-Saturday, 7:00AM-3:00AM, inclusive of holidays. The Establishment's hours of alcoholic beverage sales, service, and consumption shall not exceed the following: Sunday-Thursday, 8:00 AM-2:00 AM, and Friday-Saturday, 8:00 AM-3:00 AM, inclusive of holidays. The parties acknowledge that the foregoing hours represent the maximum legal hours for non-holiday days. In the event the law is amended to allow for later hours of operation because of a special event (for example, for an historic inauguration weekend, all-star game or Olympics in the Washington, D.C. area), the restrictions contained in this Agreement shall not prevent Applicant from operating and serving alcohol during the period of such special events.
- 2) The hours of operation for the sidewalk café shall not exceed the following: Sunday-Saturday 7:00 AM-12:00AM, inclusive of holidays. The hours of alcoholic beverage sales, service and consumption for the Establishment's sidewalk café shall not exceed the following: Sunday-Saturday 8: 00 AM-12 AM, inclusive of holidays.
- 3) There will be no amplified or unamplified music of any kind in the sidewalk café.
