3           CHAIRPERSON ANDERSON: The next on our  
4 show cause hearing (status) is case #16-CMP-  
5 00013, Cheerz, license #95178. Will the parties  
6 please approach and identify themselves for the  
7 record, please?

8           MS. PHILLIPS: Louise Phillips, Assistant  
9 Attorney General for the District of Columbia.

10          MS. WATSON: Deena Watson one of the owners  
11 from Cheerz Sports Grille.

12          CHAIRPERSON ANDERSON: Good morning, Ms.  
13 Watson.

14          MS. WATSON: Good morning.

15          CHAIRPERSON ANDERSON: Are there any  
16 preliminary matters in this case?

17          MS. PHILLIPS: No, there are not, Mr. Chair.

18          CHAIRPERSON ANDERSON: You said, Ms. Watson  
19 that you're one of the owners?

20          MS. WATSON: Yes.

21          CHAIRPERSON ANDERSON: I'm just -- the  
22 paperwork that I have in front of me just says

1 that Roxanne Dover, but I'm not sure if I have  
2 the information here that says who the ownerships  
3 are, so just give me a minute, please.

4 MS. WATSON: Okay.

5 MR. ALBERTI: So, as of mid 2014, our records  
6 show that Ms. Roxanne Dover was 100% owner. Has  
7 that -- I'm sorry, your name again?

8 MS. WATSON: Deena Watson.

9 MR. ALBERTI: Ms. Watson, do you know if -- I  
10 may be mistaken -- have you filed a change of  
11 officers with us?

12 MS. WATSON: No. There are actually three of  
13 us. I'm usually the one that comes up.

14 MR. ALBERTI: I got you, but did you file a  
15 change of ownership officially with, or add  
16 yourself to the ownership officially, with ABRA?

17 MS. WATSON: I guess not. I don't know.

18 MR. ALBERTI: Then I'll assume that our  
19 records are correct --

20 MS. WATSON: Okay.

21 MR. ALBERTI: -- and you are not -- you are  
22 not, for this hearing, an owner.

1 MS. WATSON: So, if you're an owner of the  
2 establishment then you and -- you need to correct  
3 the ABRA records to say who the actual owners  
4 are. The information we have here says -- as Mr.  
5 Alberti stated -- is that Ms. Dover is 100%  
6 owner, she has 100% ownership of this  
7 establishment.

8 MS. WATSON: Okay.

9 CHAIRPERSON ANDERSON: So that's something  
10 that I would hope that you take care of.

11 MS. WATSON: Okay.

12 CHAIRPERSON ANDERSON: This matter, then, is  
13 scheduled for a show cause hearing on September  
14 21, at 10:00 a.m.

15 MS. WATSON: Okay.

16 CHAIRPERSON ANDERSON: And if you have not  
17 changed the ownership by that point, and at that  
18 hearing either Ms. Dover needs to be here --

19 MS. WATSON: Okay.

20 CHAIRPERSON ANDERSON: -- or she needs to  
21 provide you with a letter authorizing you to  
22 enter into -- to conduct the hearing.

1 MS. WATSON: Okay.

2 CHAIRPERSON ANDERSON: Okay?

3 MS. WATSON: Okay.

4 CHAIRPERSON ANDERSON: All right, thank you.  
5 So, again, the hearing is scheduled for September  
6 21st at 10:00 a.m.

7 MS. PHILLIPS: May Ms. Watson be excused?

8 CHAIRPERSON ANDERSON: Hold on for one  
9 minute. Okay, fine. Yes, Ms. Watson, our  
10 general counsel will have a conversation with  
11 you.

12 MS. WATSON: Okay.

13 CHAIRPERSON ANDERSON: You can step back,  
14 please. Thank you.
