2 ROLL CALL HEARING

3 CHAIRPERSON FLETCHER: Would the parties
4 in the matter of Red Lounge Hookah please come
5 forward? The parties in the matter of Red Lounge
6 Hookah. This is Case #16-PRO-00055, SALMA, LLC,
7 trading as Red Lounge Hookah, 2013 14th Street
8 Northwest, license #ABRA-076011. This is a
9 Retailer Class CR, license renewal. The protest
10 issues are adverse impact on peace, order and
11 quiet. Introductions, beginning with the
12 applicant.

13 MS. HARRAG: Ouafae Harrag. OUAFAE --

14 CHAIRPERSON FLETCHER: Excuse me one second.
15 O-U-A-F as in Frank?

16 MS. HARRAG: Yes, A-E

17 CHAIRPERSON FLETCHER: That's the first name?

18 MS. HARAG: Yes, that's the first name. Last
19 name is Harrag, H-A-R-R-A-G as George.

20 CHAIRPERSON FLETCHER: Okay, thank you very
21 much. Your name, sir?

22 MR. BAH: Amadou Bah. A-M-A-D-O-U --

1 CHAIRPERSON FLETCHER: Excuse me, A-M?

2 MR. BAH: A-D-O-U.

3 CHAIRPERSON FLETCHER: Mm hmm.

4 MR. BAH: Last name B-A-H.

5 CHAIRPERSON FLETCHER: B as in boy?

6 MR. BAH: A-H.

7 CHAIRPERSON FLETCHER: A-H?

8 MR. BAH: Yeah.\

9 CHAIRPERSON FLETCHER: Okay, thank you very
10 much. And so, which one of you is going to be
11 the designated representative? We'll contact one
12 person as the designated representative. Which
13 one will that be? And so you'll be the only
14 person that needs to put your name on that --
15 there's a sheet on the table. Just your name
16 will be good.

17 MR. BAH: Okay.

18 CHAIRPERSON FLETCHER: Yeah. Present on
19 behalf of ANC 1B?

20 MR. GREEN: Commissioner John Green yet
21 again.

22 CHAIRPERSON FLETCHER: Thank you Mr. Green.

1 The ANC 1B does have standing as a protestant.
2 We need to set a date for a mediation, protest
3 hearing and status hearing. I'll give you the
4 dates for the status and the protest hearing
5 first. The date of the status hearing is
6 September 14 at 9:30. The date of the protest
7 hearing is October 26 at 1:30.

8 MS. HARRAG: October 26.

9 MR. BAH: October 26?

10 CHAIRPERSON FLETCHER: Yes, October 26 at
11 1:30.

12 MR. BAH: 1:30.

13 MS. HARRAG: Okay.

14 CHAIRPERSON FLETCHER: The next available
15 date for a mediation is Friday August 5 at 9:00,
16 10:00 or 11:00. That's Friday, August the 5th at
17 9:00, 10:00 or 11:00.

18 MR. HARRAG: 11:00 if it's possible.

19 CHAIRPERSON FLETCHER: Does that work for
20 you, Mr. Green?

21 MR. GREEN: Yes, 11:00 is fine.

22 MS. HARRAG: Is August 5th?

1 MR. GREEN: 5th.

2 MS. HARRAG: Okay.

3 CHAIRPERSON FLETCHER: Okay Friday August 5th
4 at 11:00. Any questions at all? Okay, thank
5 you, the Roll Call Hearing is concluded. Thank
6 you, Mr. Green.
