3 CHAIRPERSON ANDERSON: The next case on
4 our calendar is Case No. 19-PRO-00132, Chuck &
5 Bill Bison Lounge, License No. 14759. Would the
6 parties please approach and identify themselves
7 for the record, please?

8 MR. NEHMETALLAH: I am on behalf of the
9 Protestant, George Nehmetallah.

10 CHAIRPERSON ANDERSON: Is the owner of
11 Chuck & Bill Bison Lounge here? All right. What
12 I normally do, these matters are scheduled for
13 protest hearing at 9:30. I call the case. If
14 the person is not here, I will give them half an
15 hour to show up. What I will do, I will go
16 through the protest, in this particular case,
17 I'll go through the protest calendar and I will
18 recall this case. You can step back. I will
19 recall this case.

20 If they're not here when the case is
21 recalled, the Board will vote on the motion to
22 dismiss their license renewal. So I will recall
23 this case, okay? You can step back.

2 CHAIRPERSON ANDERSON: I would like to
3 recall Case No. 19-PRO-00132, Chuck and Bill
4 Bison Lounge, License No. 14759. Will the
5 parties please approach and identify themselves
6 for the record, please?

7 MR. NEHMETALLAH: George Nehmetallah
8 from the Protestant.

9 CHAIRPERSON ANDERSON: I'm sorry, your
10 last name, sir?

11 MR. NEHMETALLAH: George Nehmetallah.

12 CHAIRPERSON ANDERSON: Lebettelli?

13 MR. NEHMETALLAH: Nehmetallah,
14 Nehmetallah.

15 CHAIRPERSON ANDERSON: Good morning,
16 sir.

17 MR. TURNER: James Turner with the ANC
18 1B.

19 CHAIRPERSON ANDERSON: Good morning,
20 Mr. Turner. This matter was scheduled for a
21 protest hearing at 9:30. The case was initially
22 called. The Protestants were here and the
23 Licensee did not appear. I recalled the case,
24 and the Protestants are here. The Licensee has
25 failed to appear. I'm then, because of the

1 failure of the Licensee to appear and the failure
2 of the Licensee to provide reasonable notice to
3 the Board why they are not here today, I make a
4 motion that the Board dismiss the renewal
5 application. Is there a second?

6 MR. SHORT: Second.

7 CHAIRPERSON ANDERSON: Mr. Short has
8 second the motion. All those in favor say aye.

9 (CHORUS OF AYES.)

10 CHAIRPERSON ANDERSON: Those opposed?
11 The matter pass, 6-0-0. What this means is that
12 the Board will dismiss the renewal application
13 for this establishment. They will be given 10
14 days to provide the Board with reasonable notice
15 why they failed to appear today. If they fail to
16 do that, then their application is dismissed and
17 they will have to reapply again. All right?

18 MR. TURNER: Mr. Chairman?

19 CHAIRPERSON ANDERSON: Yes, sir.

20 MR. TURNER: If the Applicant is
21 reinstated, then the Party of Five and the ANC
22 will continue standing in the protest?

23 CHAIRPERSON ANDERSON: If they reapply,
24 yes. I mean, if they give reasonable notice,
25 yes, or if they have to reapply. All you have to

1 do is to reach out to the Board to ask that you
2 be reinstated.

3 MR. TURNER: Even if they've reapplied?

4 CHAIRPERSON ANDERSON: Yeah, even if
5 they reapply. You have to reach out to the
6 Agency to say that we're still protesting.

7 MR. TURNER: Thank you.

8 CHAIRPERSON ANDERSON: Okay. So
9 remember, it's on you to contact us to say that
10 we're still protesting if they reapply.

11 MR. TURNER: I understand. Thank you.

12 CHAIRPERSON ANDERSON: Thank you.
