**ORDER TO CEASE AND DESIST**

The Alcoholic Beverage Regulation Administration (ABRA) has reviewed its records and determined that Market Bars, LLC, t/a DC Reynolds, located at 3628 Georgia Avenue, N.W., Washington, D.C., has failed to pay the second year license fees for License No. ABRA-087045, a Retailer's Class CT License. Specifically, you failed to pay the license fees for the period of 2011 to 2012, for your license by September 30, 2011, the deadline for all Retailer's CT licenses, despite being notified of the payment date. Therefore, your license has been **SUSPENDED** until you pay the license fees and the \$50.00 per day fine imposed by the Alcoholic Beverage Control Board (Board) for late payment.

Pursuant to D.C. Official Code § 25-829 you are therefore **ORDERED** by the Board on this 21<sup>st</sup> day of March, 2012, to **STOP selling, serving, or permitting the consumption of alcoholic beverages at your establishment** until payment of the license fees and any associated fines are received by ABRA. You may not allow the sale of alcoholic beverages on the premises until your ABC License is reinstated by the Board.

Please be advised that a copy of this Order is being forwarded to the Metropolitan Police Department and District Wholesalers to ensure compliance. If it is found that you are continuing to sell, serve, or permit the consumption of alcoholic beverages at the establishment without approval from the Board you may be subject to the maximum civil penalties provided by the law.


