ORDER TO CEASE AND DESIST

The Alcoholic Beverage Control Board (Board) has been notified by the Department of Consumer and Regulatory Affairs (DCRA) that Jose A. and Maria R. Carcamo, t/a El Sauce Restaurant and Carry-out (Licensee), at premises 1227 11th Street, N.W., Washington, D.C., is operating without a valid Basic Business License. Specifically, the Licensee's restaurant license expired on March 31, 2011. In accordance with the laws and regulations of the District of Columbia, the Licensee shall not engage in the sale or service of alcoholic beverages unless a certificate of occupancy and all other business licenses have been issued for the business.

Pursuant to D.C. Official Code § 25-829 you are therefore **ORDERED** by the Board on this 3rd day of August, 2011, to **STOP selling, serving, or permitting the consumption of alcoholic beverages at 1227 11th Street, N.W., Washington, D.C.** You may not allow the sale of alcoholic beverages on the premises until your ABC License is reinstated by the Board.

Please be advised that a copy of this Order is being forwarded to the Metropolitan Police Department and District Wholesalers to ensure compliance. If it is found that you are continuing to sell, serve, or permit the consumption of alcoholic beverages at 1227 11th Street, N.W.,
