3 CHAIRPERSON ANDERSON: The next case
4 on our calendar is Case No. 18-251-00170, El
5 Centro D.F., License No. 604.

6 Would the parties, please, approach
7 and identify themselves for the record, please?

8 MR. SOUSA: Christopher Sousa for the
9 District of Columbia.

10 CHAIRPERSON ANDERSON: Good morning,
11 Mr. Sousa.

12 MR. KLINE: Good morning. Andrew
13 Kline on behalf of the licensee.

14 CHAIRPERSON ANDERSON: Good morning,
15 Mr. Kline.

16 Mr. Sousa, are there any preliminary
17 matters in this case?

18 MR. SOUSA: There are not.

19 CHAIRPERSON ANDERSON: All right.
20 Then this matter is scheduled for Show Cause
21 Hearing on March 20, 2019 at 10:00 a.m.

22 And I just want to advise the parties

1 that I expect that each party if we are going to
2 Show Cause Hearing, that you disclose your
3 documents and witnesses seven days prior to the
4 hearing to both sides and also to the Board.

5 All right. Thank you.

6 MR. SOUSA: I actually have a question
7 about that.

8 CHAIRPERSON ANDERSON: Yes, Mr. Sousa?

9 MR. SOUSA: I'm not personally
10 assigned to this case. Does that include the
11 investigative report? Does that rule encompass
12 the investigative report that you all already
13 have copies of?

14 CHAIRPERSON ANDERSON: I guess the
15 problem that I have been having is that, since I
16 have been here, I have folks -- no one knows what
17 documents and witnesses we are relying on.

18 MR. SOUSA: Um-hum.

19 CHAIRPERSON ANDERSON: And as an
20 attorney, I can't operate that way. So if the
21 other side has it, fine. You can identify it.
22 You don't necessarily -- since I am hoping that

1 I'm not assuming incorrectly that the other side
2 has the investigative report, but at least it
3 should be identified so we are not here searching
4 around to try to figure out what documents or
5 witnesses people are relying on.

6 MR. SOUSA: Fair enough. Noted. And
7 I'll inform my colleagues.

8 CHAIRPERSON ANDERSON: Okay. But I
9 try to inform everyone when we have the Show
10 Cause (Status) to say this is my expectation that
11 we do that. Okay?

12 MR. SOUSA: Okay. Thank you.

13 MR. KLINE: Thank you.

14 CHAIRPERSON ANDERSON: All right.

15 Thank you.
