### Voluntary (Cooperative) Agreement

Made this 11th day of December, 2007, by and between Sunnyside Group, LLC, t/a Good Stuff Eatery (the Applicant), and Advisory Neighborhood Commission 6B, (the ANC, Collectively, the "Parties").

#### WITNESSETH

WHEREAS, Applicant's application for a Retailers' Class "D" Restaurant license for premises, 303

Pennsylvania Avenue, S.E., Washington, DC, 20003, ABC License # 78027, is now pending before the District of

Columbia Alcoholic Beverage Control Board (ABC); and,

WHEREAS, the premises is within the boundaries of the ANC; and,

WHEREAS, the parties desire to enter into an agreement governing certain understandings regarding the issue of a Retailers' Class "D" Liquor License at the subject premises;

WHEREAS, the parties wish to state their mutual desire to promote the peace, order and quiet of the neighbors in the immediate area. Both parties recognize the importance of business neighborhoods that are safe, clean and "pedestrian friendly".

NOW, THEREFORE, the parties agree as follows:

- Applicant will maintain the public space adjacent to the establishment in a clean and litter-free condition by:
  - Picking up trash, including beverage bottles and cans, on a daily basis; and,
  - b. Sweeping the outside of the establishment on a daily basis; and,
  - c. Taking due diligence to prevent vermin infestation in and around the establishment, including following the recommendations and guidelines of the Vector Control Division of the Department of Public Works.
- The Applicant will not provide, or permit, a disc jockey, amplified live music or amplified live entertainment at the premises.
- The hours of operation are Sundays 11:00 a.m. 10:00 p.m.; Mondays thur Thursdays 11:00 a.m.
  - 11:00 p.m.; and Friday and Saturdays 11:00 a.m. 12:00 a.m.
- 4. Any music provided on the Premises will not be audible outside of the premises.

5. Applicant will not operate the Premises as a nightclub, dance venue or similar venue.
In consideration of, and reliance upon, the commitments reflected in paragraphs 1 thru 4 the ANC will not oppose the applicant's pending license application.

The parties further agree that any failure of Applicant to adhere to the foregoing commitment would constitute grounds for the ANC to petition the ABC Board for issuance of an order to show cause pursuant to 23 D.C.M.R. 1513.5
