**ORDER DENYING APPLICATION FOR EXCEPTION
TO SINGLE SALE RESTRICTION**

The official records of the Alcoholic Beverage Control Board (Board) reflect that Myongwoo, Inc., t/a Grand Liquors (Applicant), located at 409 15th Street, N.E., Washington, D.C., and ANC 6A entered into Settlement Agreement (Agreement), dated May 10, 2012, that governs the operation of the Applicant's establishment. The Agreement restricts the sale of individual containers of beer, malt liquor, or ale with a capacity of 70 ounces or less, as well as individual containers of wine in a single containers with the capacity of less than 750 milliliters.

On March 22, 2013, the Applicant submitted an Application for an Exception to Single Sales Restriction, which was opposed by ANC 6A. ANC 6A notified the Alcoholic Beverage Control Board (Board) of its opposition on February 28, 2013.

On May 8, 2013, pursuant to District of Columbia (D.C.) Official Code § 25-346 (c) (1) the Board held a Fact Finding Hearing to consider the Applicant's Application for Exception to Single Sales Restriction that currently exists in Ward 6.

Pursuant to the D.C. Official Code § 25-346 (c) (3) “a new licensee under an off-premises retailer's license, class A or B, may not apply for an exception under this subsection within the first 12 months of having obtained a license under this title.”

The Board takes administrative notice that the license was approved on May 16, 2012 and issued on July 20, 2012. The Application for an Exception to Single Sales Restriction was filed on March 22, 2013; therefore, the Applicant's Application is premature.

As such, the Board denies the Applicant's Application for an Exception to Single Sales Restriction because the Applicant is barred from filing for an exception until after July 20, 2013 pursuant to D.C. Official Code § 25-346 (c) (3).

Accordingly, it is this 17th day of July, 2013, **ORDERED** that the Application filed by Myongwoo, Inc., t/a Grand Liquors, for an Exception to Single Sales Restriction at the location 409 15th Street, N.E., Washington, D.C., is **DENIED**.




