2 STATUS

3 CHAIRPERSON ANDERSON: Our next case is
4 Case #16-CMP-00279, Hot and Juicy Crawfish,
5 license #86226. Will the parties please approach
6 and identify themselves for the record?

7 MR. SHAPIRO: Thank you, good morning,
8 Zachary Shapiro on behalf of the District of
9 Columbia.

10 CHAIRPERSON ANDERSON: Good morning, Mr.
11 Shapiro.

12 MS. LAM: Good morning, my name is Alice Lam,
13 I'm the manager of Hot and Juicy Crawfish.

14 CHAIRPERSON ANDERSON: Alice who?

15 MS. LAM: Alice Lam.

16 CHAIRPERSON ANDERSON: Hi, Ms. Lam. Just for
17 the record, I want the record to reflect that I
18 actually went to Hot and Juicy Crawfish yesterday
19 for dinner, so I just wanted the record to
20 reflect that. But anyway, I'm sorry. Are there
21 any preliminary matters in this case?

22 MR. SHAPIRO: Yes, there is an offer in

1 compromise.

2 CHAIRPERSON ANDERSON: And what is that?

3 MR. SHAPIRO: The offer in compromise is a
4 fine of \$2000 payable in thirty days or the
5 license will be suspended. That's the only
6 charge.

7 CHAIRPERSON ANDERSON: Hold on one minute.
8 Ms. Lam have you provided the Board with any
9 representation to say that you're authorized to
10 bind the --

11 MS. LAM: I did and I did submit it last week
12 and I brought a copy as well.

13 CHAIRPERSON ANDERSON: Do you have that, Ms.
14 Walker? All right. Ms. Lam is authorized by the
15 owner to represent the agency. So, Ms. Lam, it's
16 my understanding that there's an offer in
17 compromise of a fine of \$2000 payable in what --
18 thirty days?

19 MR. SHAPIRO: Thirty days.

20 CHAIRPERSON ANDERSON: Payable in 30 days and
21 that if this fine is not payable in 30 days that
22 the license will be suspended until the fine is

1 paid. Is this your understanding of the offer in
2 compromise, ma'am?

3 MS. LAM: Yes.

4 CHAIRPERSON ANDERSON: And are you aware that
5 by accepting an offer in compromise that you're
6 giving up your right to a hearing?

7 MS. LAM: Yes.

8 CHAIRPERSON ANDERSON: And are you also aware
9 that by accepting this offer in compromise that
10 you're giving up your right to appeal this
11 matter?

12 MS. LAM: Yes.

13 CHAIRPERSON ANDERSON: All right, thank you.
14 Do we have any questions by the Board members?
15 Hearing none, I then make a motion that this
16 offer in compromise of a fine of \$2000 payable in
17 30 days be accepted and that if it is not payable
18 in 30 days the license will be suspended until
19 compliance is made. Is there a second?

20 MS. MILLER: Second.

21 CHAIRPERSON ANDERSON: Ms. Miller has
22 seconded the motion. Those in favor say Aye.

1 [Chorus of ayes] Those opposed? [No audible
2 response.] The matter passed 5-zero-zero. Thank
3 you very much. Ms. Lam, don't leave. Ms. Walker
4 will bring something for you to sign, please.
5 Okay? All right. Thank you very much.
