ORDER SUA SPONTE DISMISSING CASE NO. 15-251-00001

THIS CASE is before the Alcoholic Beverage Control Board (Board) *sua sponte*.

The Board executed a Notice of Status Hearing and Show Cause Hearing (Notice), on March 25, 2015. The Notice charged Heritage Management Service LLC t/a Heritage India/The Zanzibar (Respondent) with the following violations:

- Charge I: The Licensee allowed the licensed establishment to be used for an unlawful or disorderly purpose, in violation of D.C. Official Code §25-823 (2).
- Charge II: The Licensee interfered with an investigation conducted by the Metropolitan Police Department and ABRA, in violation of D.C. Official Code §25-823 (5).
- Charge III: The Licensee failed to comply with the provisions of its Security Plan and Settlement Agreement, in violation of D.C. Official Code §25-823 (6).

ABRA Show Cause File No. 15-251-00001, Notice of Status Hearing and Show Cause Hearing, (March 25, 2015).

Pursuant to the Notice, the Show Cause Status Hearing is scheduled for June 3, 2015, and the Show Cause Hearing is scheduled for July 29, 2015.

On April 29, 2015, the Board cancelled the Respondent's Retailer's Class CR license for failure to make the third year payment of its licensing fees. *See* Board Order No. 2015-227. The Board finds that as a result of the cancellation of the Respondent's license and the subsequent termination of its operations, it is now administratively economical and efficient to forego the adjudication of this case.

ORDER

Therefore, for the reasons stated above the Board, on this 6th day of May, 2015, *sua sponte* **DISMISSES** Case No. 15-251-00001 and **CANCELS** all hearings related to this matter.







Pursuant to D.C. Official Code § 25-433, any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14th Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
