**ORDER VACATING CANCELLATION OF LICENSE AND  
REINSTATING LICENSE**


Alvin D. Carter, t/a Hitching Post Restaurant located at 200 Upshur Street, N.W., Washington, D.C., failed to renew its Retailer's Class CT License, by September 30, 2010, the deadline for all Retailer's Class CT licenses, despite being notified by the Alcoholic Beverage Regulation Administration (ABRA) of the renewal date.

On October 20, 2010, the Alcoholic Beverage Control Board (Board) issued Board Order No. 2010-519 ordering the Applicant to cease and desist selling, serving, and permitting the consumption of alcoholic beverages on its property. *See Board Order No. 2010-519.* An ABRA Investigator served the Order to the Applicant. The Board then issued Board Order No. 2010-556, which cancelled the Applicant's license. *See Board Order No. 2010-556.* ABRA mailed the Order to the Applicant and no returned mail was received by ABRA. Nonetheless, on December 14, 2010, the Applicant submitted a Renewal Application to ABRA and paid a licensing fee of \$1,300.00 and a late fee of \$1,300.00.






