**ORDER ON DISMISSAL OF PROTEST**

The Application filed by Hu's Wear, LLC, t/a Hu's Wear, for a new Retailer's Class CR License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on October 12, 2010, in accordance with D.C. Official Code § 25-601 (2001).

On October 12, 2010, pursuant to Title 23 of the District of Columbia Municipal Regulations ("23 DCMR") § 1602.3 (2004), the Board dismissed the Protest because the Protestant failed to appear at the Roll Call Hearing. The Applicant, ANC 2E, and CAG have entered into a Voluntary Agreement, which is pending review by the Board. The Protestant may file a Request for Reinstatement with the Board within ten (10) days from the date of this Order.

**ORDER**


