1 of \$6000 payable within ten days.

2 MR. FONSECA: Yes, that is agreeable to us.

3 We can -- in all likelihood the payment will occur no

4 later than Friday. There's a matter of making sure

5 that we get the check cut. I understand now from

6 communications with Ms. Kia it could possibly be cut

7 today. So payment will likely be tomorrow or Friday at

8 the latest.

9 CHAIRPERSON MILLER: Okay. And does Ms. Kia

10 understand that she waives her right to hearing by

11 accepting an offer in compromise?

12 MS. KIA: Yes, I do.

13 CHAIRPERSON MILLER: Okay. All right. Are

14 there any questions by Board members regarding this

15 offer in compromise?

16 MR. FONSECA: If I may on the record also,

17 you know, this is a failure to have an entertainment

18 endorsement. On Monday we did file for an

19 entertainment endorsement. There are no planned events

20 until New Year's Eve. So hopefully this will be acted

21 upon by the Board and argued as a no substantial change

22 because the central business district -- it is a hotel.

2 If it does have to be placarded, then we may

8 compromise of \$6000 to be paid within ten days.

9 Do I have a second?

10 MR. NOPHLIN: Second.

11 CHAIRPERSON MILLER: And Mr. Nophlin has
12 seconded the motion. Any other comments?

13 (No audible response.)

14 CHAIRPERSON MILLER: All those in favor of
15 the offer in compromise -- for the motion to accept
16 that offer in compromise, say aye?

17 (Chorus of ayes.)

18 CHAIRPERSON MILLER: All those opposed?

19 MR. JONES: Opposed.

20 CHAIRPERSON MILLER: All those abstaining?

21 (No audible response.)

22 CHAIRPERSON MILLER: Then the vote is 5-1-0

1 to accept the offer in compromise. Thank you.
