Settlement Agreement

This agreement is made and entered into on this 25^{14} day of 5024 2013 by and between the Applicant (Restaurant Seki, LLC t/a Izakaya Seki) and Samer Bitar (protestant/abutting property owner).

The Applicant and the Protestant agree as follows:

Noise Suppression: The Applicant agrees to take the necessary steps to address the noise issue by installing drywall and insulation in the exposed area of the parti-wall and pads on the furniture, as recommended by the Protestant.

The Applicant has received an estimate from a contractor to install the insulation and drywall in the exposed area of the parti-wall and will install and maintain anti-friction pads on the legs of furniture causing vibration noise when dragged. The Applicant will have the work completed within fifteen (15) calendar days from the date of this agreement.

The Protestant agrees that once the above referenced work has been completed, to consider the issue of noise suppression with respect to insulation within the establishment to be resolved.

<u>Trash</u>: The Applicant agrees to keep trash contained in bins with the lids closed and will add an extra trash bin if necessary. Applicant further agrees to post a sign reminding employees that lids must be closed at all times.
