OF THE SINGLE SALE EXCEPTION**

The official records of the Alcoholic Beverage Control Board (Board) reflect that Bhuller's Corporation, t/a JJ Mutt Wine & Spirits, located at 643 Pennsylvania Avenue, S.E., Washington, D.C., has applied for a Renewal of the Exception to Single Sales Restriction.

The Board considered several factors in reaching its decision. This included the absence of any primary or secondary tier violations within twelve months preceding the date of the Application and ANC 6B supports this request, as demonstrated in its letter, dated March 15, 2012, indicating that ANC 6B supports the Applicant's request to renew the Exception to Single Sales Restriction.

The Board finds no significant adverse impact and grants the Application.

3. Copies of this Order shall be sent to the Applicant and ANC 6B.






