
**ORDER CANCELLING LICENSE UNDER TITLE 23 OF THE DISTRICT OF
COLUMBIA MUNICIPAL REGULATIONS § 405.1**


The Alcoholic Beverage Regulation Administration (ABRA) has reviewed its records and determined that Matador, LLC's, t/a La Pata Negra, located at 1612 14th Street, N.W., Washington, D.C., License No. ABRA-076293, was approved by the Alcoholic Beverage Control Board (Board) under Title 23 of the District of Columbia Municipal Regulations (DCMR) § 405.1, which authorized the Board to approve a license to an applicant before the issuance of a certificate of occupancy for the building in which the licensed premises shall be located.

ABRA records show that since 2009 no payments or activities have been made for this license. In addition, the Licensee's location is currently occupied by a new license-holder. ABRA's Licensing Division provided written notice to the Licensee on January 27, 2012, with no subsequent response.

It is hereby **ORDERED** on this 7th day of March, 2012, that Matador, LLC's License No. ABRA-076293 is **CANCELLED**. A copy of this Order shall be sent to the Licensee.




