ORDER ON DISMISSAL OF PROTEST OF THOMAS HALL

The Application filed by Style Concept Studio, LLC, t/a Le Chat Noir, for renewal of its Retailer's Class CR License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on May 13, 2013, in accordance with D.C. Official Code § 25-601 (2001).

On April 29, 2013, Thomas L. Hall filed a protest against the renewal of the license. Mr. Hall resides at 4118 Emery Place, N.W., Washington, D.C., and his home is adjacent to the rear of the premises.

At the Roll Call Hearing, on May 13, 2013, the Board's agent informed Mr. Hall that his residential property does not share a common wall, and thus he is not an abutting property owner who qualifies for standing under D.C. Official Code § 25-601(1).


Mr. Hall may file a Request for Reinstatement with the Board within ten (10) days from the date of this Order.




