**ORDER VACATING CANCELLATION OF LICENSE AND
REINSTATING LICENSE**

On May 15, 2019, the Alcoholic Beverage Control Board (Board) cancelled the Retailer Class CR License ABRA-105256 held by LPQ 14th & K Street, Inc., t/a Le Pain Quotidien, because 1401 K Street, NW failed to renew its license by March 31, 2019. *See* Board Order No. 2019-410.

On June 4, 2019, Stephen J. O'Brien, Esq., on behalf of LPQ 14th & K Street, Inc. (Petitioner), sought reinstatement of the Retailer's Class CR License ABRA-105256. In support of his request for reinstatement, Mr. O'Brien stated that the Petitioner was unable to renew its license due to changes in the entity's corporate documents and issues with the Office of Tax and Revenue. Mr. O'Brien now informs the Board that the Petitioner's corporate changes have been approved and the Clean Hands certificate has been procured.

The Board finds that the reinstatement of the license is proper conditioned upon the requirement that the Petitioner renews its license and pays the required fees.


Accordingly, it is this 12th day of June, 2019, **ORDERED** that the **ORDER CANCELLING LICENSE** issued against LPQ 14th & K Street, Inc., t/a Le Pain Quotidien, by the Board on May 15, 2019, be and hereby is **VACATED**.

IT IS FURTHER ORDERED that the Retailer's Class CR License ABRA-105256 be **REINSTATED**.

IT IS FURTHER ORDERED that the Petitioner renew and pay the required fees within two (2) weeks from the date of this Order.

A copy of this Order shall be sent to the Petitioner.





Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14th Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
