The Application filed by Lee's Mini Market, Inc., t/a Lee's Mini Market, for a Class Change from a Retailer's Class B License to a Retailer's Class A License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on October 15, 2013, in accordance with D.C. Official Code § 25-601 (2001).

On October 15, 2013, the Board dismissed the Protest of Fort Davis Civic Association, because Fort Davis Civic Association did not give the Applicant at least seven days advanced notice of the Fort Davis Civic Association meeting, pursuant to D.C. Reinstatement with the Board within ten (10) days from the date of this Order



ORDER




