

INSTRUCTIONS AND BILL FOR THIRD YEAR PAYMENTS FOR ALCOHOLIC BEVERAGE CONTROL LICENSES

PLEASE NOTE CHANGES IN PROCEDURE

MAIL-IN PAYMENTS: You may now mail in your payment for the third year annual license fee along with any endorsement fees. Print your name and title, sign your name and date this form. Indicate the name of your establishment and the license number on your check or money order. The completed form and your check or money order must be placed in an envelope and mailed to the Alcoholic Beverage Regulation Administration, 2000 14th Street, NW, 4th Floor, Washington, DC 20009.

FEE: License fee payments for the licensed establishment listed below must be POSTMARKED by March 31, 2012. All mail-in payments must be made in the form of a cashier's check, certified check, business check, attorney's check, personal check, or money order, payable to the D.C. Treasurer. CREDIT CARD PAYMENTS WILL NOT BE ACCEPTED THROUGH THE MAIL. DO NOT SEND CASH. Please be advised that if the postmark date is after March 31, 2012, you will be notified of the assessed late fee.

LATE FEES: Beginning April 2, 2012, a late fee will be imposed pursuant to Title 23, D.C. Municipal Regulation § 208.2 which states: "The Board may impose a late fee upon a licensee for failure to timely remit the second or third year fee, or the renewal fee, in the amount of fifty dollars (\$50.00) for each day after the due date of payment. [This late fee will be imposed if your payment is not postmarked by March 31, 2012.] The total amount of the late fee to be paid to ABRA shall not exceed the annual cost of the license. The Board may suspend a license until the licensee pays the second or third year fee and any additional fee imposed by the Board for late payment."

suspension of License: On April 18, 2012, information will be sent to the ABC Board to suspend your license in the event that payment has not been received. District wholesalers and the Metropolitan Police Department will also be notified on April 18, 2012 that you cannot sell or serve any alcoholic beverages. For additional information, please do not hesitate to contact the Licensing Division at (202) 442-4423, between the hours of 9:00 a.m. and 4:00 p.m., Monday through Friday. Your continued compliance is appreciated.
