2 ROLL CALL HEARING

3 CHAIRPERSON FLETCHER: Would the parties in
4 the matter of MASA 14 please come forward? This
5 is Case #16-PRO-00052. Sula, LLC, trading as
6 MASA 14. 1825 14th Street Northwest. License
7 #ABRA-081469. This is a Retailer Class CR,
8 license renewal. The protest issues are adverse
9 impact on peace, order and quiet. Introductions
10 beginning with the applicant, please.

11 MR. O'BRIEN: Stephen O'Brien for the
12 applicant, I'm accompanied by Ayyaz Rashid.

13 CHAIRPERSON FLETCHER: Mr. Rashid --

14 MR. OBRIEN: You had the name spelled for the
15 reporter in the last matter.

16 CHAIRPERSON FLETCHER: Is that okay? Thank
17 you. Okay, ANC 1B has standing as a protestant.
18 We need to set a date for mediation, a status
19 hearing, and a protest hearing. I'll give you
20 the date for the status hearing first. The
21 status hearing is set for September 14th at 9:30
22 a.m. The protest hearing is set for October 19th

1 at 4:30.

2 MR. O'BRIEN: Ms. Fletcher, I note that 4:30
3 on the 19th was the protest date for the previous
4 matter.

5 CHAIRPERSON FLETCHER: Yeah, they --

6 MR. OBRIEN: Are we setting two for the same
7 hour?

8 CHAIRPERSON FLETCHER: Yes.

9 MR. OBRIEN: Okay.

10 CHAIRPERSON FLETCHER: Or three.

11 MR. OBRIEN: As far as mediation goes?

12 CHAIRPERSON FLETCHER: Did you want to set it
13 on the 28th?

14 MR. OBRIEN: The 28th? Yeah, 1:00.

15 CHAIRPERSON FLETCHER: 1:00?

16 MR. OBRIEN: Yeah.

17 MR. GREEN: Would it be possible to have the
18 status the same as El Centro as well?

19 CHAIRPERSON FLETCHER: Those hearings were
20 set based on the Board's calendar, but I'll make
21 a note of that and Mr. Green you can send an e-
22 mail to Martha Jenkins. You have her e-mail

1 address, yes?

2 MR. GREEN: Yes

3 CHAIRPERSON FLETCHER: And ask her if it can
4 be switched to the 7th. She can make the
5 adjustment on the Board's calendar.

6 MR. O'BRIEN: If I may suggest, we should
7 send an e-mail to Ms. Jenkins with a copy to me
8 requesting that the El Centro status hearing be
9 moved to the 14th and you can represent in that
10 e-mail that I consent to that.

11 CHAIRPERSON FLETCHER: Okay.

12 MR. GREEN: That works for me.

13 CHAIRPERSON FLETCHER: Well, thank you. That
14 Roll Call Hearing is concluded.
