**ORDER TO CEASE AND DESIST**

The Alcoholic Beverage Control Board (Board) has determined that Bouzid, Inc., t/a Marrakesh Palace Pasha Lounge, located at 2147 P Street, N.W., Washington, D.C., a Retailer's Class CT License, does not have a valid lease at the premises address.

Mad, LLC is not allowed to sell, serve, or permit the consumption of alcoholic beverages at 2147 P Street, N.W., Washington, D.C., because it does not have an ABC License.

Pursuant to D.C. Official Code § 25-829 you are therefore **ORDERED** by the Board on this 20th day of June, 2012, to **STOP selling, serving, or permitting the consumption of alcoholic beverages at 2147 P Street, N.W., Washington, D.C.** You may not allow the sale of alcoholic beverages on the premises until your ABC License is reinstated by the Board.

Please be advised that a copy of this Order is being forwarded to the Metropolitan Police Department and District Wholesalers to ensure compliance. If it is found that you are continuing to sell, serve, or permit the consumption of alcoholic beverages at 2147 P Street, N.W., Washington, D.C., without approval from the Board, you may be subject to the maximum civil penalties provided by the law.




