ORDER CANCELLING LICENSE

The Alcoholic Beverage Regulation Administration (ABRA) has reviewed its records and determined that Mio, DC, LLC, t/a Mio Restaurant (Respondent), has failed to renew its License No. ABRA-076072, a Retailer's Class CR license. Specifically, the Respondent failed to renew its license by March 31, 2016, the deadline for all Retailer's Class CR licenses, despite being notified of the renewal date.

On April 27, 2016, the Alcoholic Beverage Control Board (Board) issued an Order to Cease and Desist against Mio, DC, LLC, t/a Mio Restaurant, pursuant to D.C. Official Code § 25-829 (2001), for failure to renew its Retailer's Class CR License. ABRA's Enforcement Division confirmed that the Respondent is out of business.

However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion, See D.C. App. Rule 15(b) (2004).
