ORDER TO CEASE AND DESIST

The Alcoholic Beverage Control Board (Board) has been notified by the Department of Public Health (DOH), Food Safety and Hygiene Inspection Services Division, that JC 7, LLC, t/a NY NY Diva's (Licensee), at premises 2406-2408 18th Street, N.W., Washington, D.C., was issued a Summary Suspension on June 12, 2014, for rats and other critical violations by DOH, in violation of District of Columbia Food Code Regulations (Title 25 of the District of Columbia Municipal Regulations (DCMR)) which presents an eminent health hazard(s) to the public. In accordance with the laws and regulations of the District of Columbia, the Licensee shall not engage in the sale or service of alcoholic beverages if the Licensee presents an imminent danger to the health and safety of the public, pursuant the D.C. Official Code § 25-826(a).

Pursuant to D.C. Official Code § 25-829 you are therefore **ORDERED** by the Board on this 18th day of June, 2014, to **STOP selling, serving, or permitting the consumption of alcoholic beverages under your Retailer's Class CR License No. ABRA-092380**. You may not allow the sale of alcoholic beverages until your ABC License is reinstated by the Board.

Please be advised that a copy of this Order is being forwarded to the Metropolitan Police Department, District Wholesalers and DOH to ensure compliance. If it is found that you are continuing to sell, serve, or permit the consumption of alcoholic beverages under your Retailer's Class CR License No. ABRA-092380 without approval from the Board, you may be subject to the maximum civil penalties provided by the law.




