1 P R O C E E D I N G S

2 CHAIRPERSON ANDERSON: All right. We move
3 onto our next show cause hearing, Case -- Case Number
4 15-CMP-00800, Parlay, License Number 97074. Will the
5 parties please approach and identify themselves for the
6 record please.

7 MS. GEPHARDT: Chrissy Gephardt here on
8 behalf of the Office of the Attorney General.

9 CHAIRPERSON ANDERSON: I didn't hear your
10 name, sir.

11 MR. JELENCOVICH: Mike Jelencovich, owner.

12 CHAIRPERSON ANDERSON: Jelencovich?

13 MR. JELENCOVICH: Yes.

14 CHAIRPERSON ANDERSON: There's a sign-in
15 sheet there. Could you please sign in, sir.

16 Ms. Gephardt, are there any preliminary matters in this
17 case?

18 MS. GEPHARDT: Yes, there is, Mr. Chairman.
19 In this case we have agreed -- the parties have agreed
20 on an Offer in Compromise to consist of a \$1,250 fine,
21 and that fine would be paid within 60 -- within 60 days.
22 And if the fine is not paid within 60 days, the license

1 would be suspended pending the payment of the fine.

2 CHAIRPERSON ANDERSON: All right.

3 Mr. Jelencovich --

4 MR. JELENCOVICH: Yes, sir.

5 CHAIRPERSON ANDERSON: -- it's my
6 understanding that you have agreed to an Offer in
7 Compromise with the Government and the Offer in
8 Compromise is that a fine of \$1,250 will be paid within
9 60 days. If the fine is not payable in 60 days, your
10 license will be suspended to operate until you have paid
11 the fine. Is this your -- is this your understanding of
12 the Offer in Compromise, sir?

13 MR. JELENCOVICH: Yes, sir.

14 CHAIRPERSON ANDERSON: And are you aware by
15 accepting an Offer in Compromise that you're giving up
16 your right to have a hearing?

17 MR. JELENCOVICH: Yes, sir.

18 CHAIRPERSON ANDERSON: And are you also
19 aware that by accepting this offer you're also giving up
20 your right to appeal this matter?

21 MR. JELENCOVICH: Yes, sir.

22 CHAIRPERSON ANDERSON: All right. I then

1 make a motion that this Offer in Compromise of a fine of
2 \$1,250 be -- payable in 60 days be acceptable. If it's
3 not -- if it's not paid in 60 days, the license will be
4 suspended until compliance of -- until it's paid. Is
5 there a second?

6 MS. MILLER: Second.

7 CHAIRPERSON ANDERSON: Ms. Miller has
8 seconded the motion. Any -- any discussions by any
9 board members? Hearing none, all those in favor say
10 aye. [Chorus of ayes]. All those opposed.

11 MR. ALBERTI: Opposed.

12 CHAIRPERSON ANDERSON: The matter passed 4
13 to 1 with Mr. Alberti in opposition. All right. Thank
14 you, sir. We'll have you sign off on some paperwork on
15 this. Thank you.

16 MR. JELENCOVICH: Thank you.

17 CHAIRPERSON ANDERSON: We're off the record
18 for a minute. We'll be in recess until 11:00. All
19 right. Thank you.
