2. Copies of this Order shall be sent to the Licensee and Advisory Neighborhood Commission 6D.







Re: Correction of Voluntary Agreement dated August 11, 2009 between JTC, Inc., t/a Parkway Wine and Spirits and ANC6D

The ANC6D, at its meeting of July 12, 2010, with a quorum present, a quorum being four members, voted 4 to 0 to make the following correction of paragraph 9, section B of the Voluntary Agreement for Parkway Wine and Spirits dated August 11, 2009:

1- Sentence B1 is corrected to read: "Licensee agrees not to sell ½ pints of spirits or less, but is permitted to sell spirits in the quantity of 375 mL or larger." [The correction is because the reference to "750 ml containers" is confusing and would prohibit the sale of pints of spirits by the licensee.]

2- Sentence B2 is corrected to add at the end: "if packaging of two or more containers is received in that configuration from the manufacturer/seller." [The correction is to remove any implication that the licensee may break down a manufacturer's six-pack and sell two containers separately.]
