4 to our Show Cause Hearing (Status) and the first
5 case on our Show Cause Hearing (Status) is Case
6 No. 18-CMP-00030, Piola, License No. 87595.

7 Will the parties for Piola, please,
8 appear?

9 MS. SCHMIDT: Good morning, Amy
10 Schmidt, Assistant Attorney General on behalf of
11 the District of Columbia.

12 CHAIRPERSON ANDERSON: Good morning,
13 Ms. Schmidt.

14 MS. SALGUERO: Good morning. My name
15 is Rosemarie Salguero from the Law Firm of
16 Greenberg Traurig. And I have previously
17 submitted, but I can submit it again, an Attorney
18 Designation form.

19 CHAIRPERSON ANDERSON: Thank you, Ms.
20 Salguero.

21 MS. SALGUERO: Salguero, S-A-L-G-U-E-
22 R-O.

1 CHAIRPERSON ANDERSON: Ms. Salguero,
2 good morning.

3 MS. SALGUERO: Good morning.

4 CHAIRPERSON ANDERSON: All right.
5 Good morning, Ms. Schmidt. Are there any
6 preliminary matters in this case?

7 MS. SCHMIDT: Yes, there is. There is
8 an Offer in Compromise which consists of the
9 cancellation of the license to be done today.

10 CHAIRPERSON ANDERSON: All right. All
11 right. Ms. Salguero, it's my understanding that
12 there is an Offer in Compromise and the Offer in
13 Compromise is that the establishment will be
14 canceling its license immediately?

15 MS. SALGUERO: That is correct.

16 CHAIRPERSON ANDERSON: And so does
17 that mean that when -- so when will the license
18 be turned over to ABRA?

19 MS. SALGUERO: Currently, the license
20 is in safekeeping. It has been in safekeeping, I
21 think, since March or so, so it is in ABRA's
22 possession.

1 CHAIRPERSON ANDERSON: Okay. All
2 right. All right. So does your client -- is
3 your client aware that by accepting an Offer in
4 Compromise, that they are giving up their right
5 to appeal this matter?

6 MS. SALGUERO: Yes.

7 CHAIRPERSON ANDERSON: And is your
8 client aware that by accepting an Offer in
9 Compromise, that they are giving up their right
10 to appeal this matter?

11 MS. SALGUERO: Correct.

12 CHAIRPERSON ANDERSON: With that said,
13 I then make -- is there any questions by any
14 Board Members?

15 With that said, I make a motion that
16 the Offer in Compromise that the establishment
17 will be canceling its license immediately be
18 accepted. Is there a second?

19 MEMBER SHORT: Second.

20 CHAIRPERSON ANDERSON: Mr. Short has
21 seconded the motion.

22 All those in favor say aye.

1 ALL: Aye.

2 CHAIRPERSON ANDERSON: Those opposed?

3 The matter passes 6-0-0.

4 Thank you very much. I mean, are we
5 going to issue a Board Order?

6 MS. SALGUERO: Yes.

7 CHAIRPERSON ANDERSON: The Board will
8 be issuing a Board Order on this matter. Thank
9 you.

10 MS. SALGUERO: Thank you.
