The official records of the Alcoholic Beverage Control Board (Board) reflect that Potomac Riverboat Company, LLC (Applicant), and ANC 6D entered into a Cooperative

Agreement (Agreement), dated September 11, 2017, in accordance with D.C. Official Code § 25-446 (2001).

The Agreement has been reduced to writing and has been properly executed and filed with the Board. The Applicant and Chairperson Andy Litsky and Dr. Coralie Farlee, on behalf of ANC 6D, are signatories to the Agreement.

Accordingly, it is this 20th day of September, 2017, **ORDERED** that:

- 1. The above-referenced Cooperative Agreement submitted by the parties to govern the operations of the Applicant's establishment is **APPROVED** and **INCORPORATED** as part of this Order;
- 2. This Cooperative Agreement replaces and supersedes previous Cooperative Agreements between the parties; and
- 3. Copies of this Order shall be sent to the Applicant and ANC 6D.

COOPERATIVE AGREEMENT

This COOPERATIVE AGREEMENT replaces the Cooperative Agreement between Potomac Riverboat Company, LLC (with three boats), and ANC6D dated June 24, 2015, and approved and executed by ABC Board Order 2015-316 dated June 24, 2015.

THIS COOPERATIVE AGREEMENT ("Agreement") is made on this 11th day of September 2017 by and between Potomac Riverboat Company, LLC t/a Mathew Hayes (#1), Commander Jacques (#2), Miss Christin (#3), Potomac Taxi I (#4), Potomac Taxi II (#5), Potomac Taxi III (#6), and Potomac Taxi IV (#7) ("Licensee") and Advisory Neighborhood Commission 6D ("ANC"), (collectively, the "Parties"). This agreement is for Class DX License #098753 to include the seven marine vessels listed above. Vessels #1, #2, and #3-dock at Alexandria, VA, 22314 and load at the Diamond Teague Park in SE DC. Vessels #4, #5, #6, and #7 dock at the Wharf in SW Washington DC, 20024 and provide water taxi services with stops including: Alexandria, VA; The Wharf in SW DC; National Harbor in Maryland; and Georgetown waterfront in NW DC. Additional water taxi stops may be added in the future.

WITNESETH

WHEREAS, Potomac Riverboat Company, LLC holds License Class DX #098753 with no endorsements for each of three (3) marine vessels operating under the Potomac Riverboat Company, LLC with offices located at 211 N. Union Street, #250, Alexandria, VA 22314. The three marine vessels are: Mathew Hayes #1, total occupancy load of 149; Commander Jacques #2, total occupancy load of 122; and Miss Christin #3, total occupancy load of 173. Licensee may add the following four (4) additional marine vessels to this license: Potomac Taxi I (#4), Potomac Taxi II (#5), Potomac Taxi III (#6), and Potomac Taxi IV (#7). Each of the four additional Potomac Taxi vessels will have a total occupancy load not to exceed 200 per vessel. These seven marine vessels will be included in its Retailer's Class DX ABC license (#098753).

WHEREAS, the Parties have agreed to enter into this Agreement and

request that the Alcoholic Beverage Control Board ("ABC Board") approve the addition of the four vessels to Licensee's Retailer's Class DX ABC license (#098753) conditioned upon the Licensee's compliance with the terms of this written Agreement; and

WHEREAS, the Parties are desirous of entering into a Cooperative Agreement pursuant to D.C. Official Code § 25-446 for the operation and maintenance of the Licensee's business in such a manner as to minimize the effect on the peace, order and quiet of the neighborhood, and to eliminate the need for a Protest Hearing regarding the license application.

NOW, THEREFORE, in consideration of the recitals set forth above and the mutual covenants and conditions set forth below, the Parties agree as follows:

- 1. Recitals Incorporated. The recitals set forth above are incorporated herein by reference.
- 2. Nature of the Business. The Licensee will manage and operate three marine vessels (#1, #2, #3) which offer approximately a total of 100 ferry trips annually from Alexandria, Virginia to the Diamond Teague Park, 100 Potomac Avenue, SE, depending on the number of events occurring at Nationals Park. The usual duration of each trip is approximately ½ hour each way.

The Licensee will also manage and operate four additional vessels (#4, #5, #6, #7) which offer approximately 3,000 trips in total annually. The Licensee's additional four vessels will provide water taxi services with stops including: Alexandria, VA; The Wharf in SW DC; National Harbor in Maryland; and Georgetown waterfront in NW DC. Additional stops may be added in the future. The usual duration of each trip is between 25 and 40 minutes.

Alcohol service is available throught out each trip; provided, that no passenger is permitted to disembark with alcoholic beverages. On those rare occasions (charter trips) when recorded music is presented, such will be confined to the interior decks. Gambling is not allowed but game nights with no monetary prizes are allowed.

3. Hours of Operation.

The Licensee's hours of operation and sales, service, and consumption of alcoholic beverages shall be as follows:

Sunday through Saturday, 8:00 a.m. to 2:00 a.m.

4. Floors Utilized and Occupancy. The Licensee currently manages and operates three marine vessels: Mathew Hayes, Commander Jacques, both of which are single deck vessels, and Miss Christin which has two floors/decks. Licensee may also manage and operate the following four marine vessels to added to its DX license: Potomac Taxi I (#4), Potomac Taxi II (#5), Potomac Taxi III (#6), and Potomac Taxi IV (#7). Each of the four Potomac Taxi vessels has two floors/decks.

In total, the seven marine vessels' total occupancy will not exceed 1,250 (all seated) patrons.

- 5. Sidewalk Café. There is no sidewalk café; no food or alcohol service shall be available in the pre-boarding or waiting areas.
- 6. Noise and Privacy. Licensee will strictly comply with D.C. Official Code § 25-725 and to that end shall take all necessary actions to ensure that music, noise and vibration from the vessels is not audible within any of the properties or areas that the cruises pass by. Sound on vessels shall be reduced when exiting and entering the Anacostia River, and the SW Potomac River channels (or areas).
- 7. Public Space and Trash. Licensee shall not deposit or discard any litter, bottles, and other debris from any vessel at Diamond Teague Park and shall dispose of all such materials at Alexandria, Virginia. Licensee may deposit or discard any litter, bottles, trash and other debris from vessels #4, #5, #6, and #7, at The Wharf in its designated interior trash room located on BlairAlley, SW.
- 8. Security Cooperation in Stemming Illegal Drugs and Public Drinking.
 The ANC is concerned that the nature of the business of the Licensee will not pose security and crime issues. Licensee agrees that it shall take all necessary steps to minimize such problems, including, without limitation,

designating a sufficient number of employees to assure adequate security and to control unruly patrons, whether inside or in the immediate outside area; monitoring for and prohibiting sales or use of illegal drugs within or about any of the licensed vessels, maintaining contact and cooperating with the Harbor Patrol and /or Metropolitan Police Department and other enforcement officials when known or suspected drug activities occur.

Licensee shall check IDs of patrons who appear to be under the age of 35.

Licensee shall maintain a log on each marine vessel to record any security incidents and include in the log: the nature of the incident, who was involved, and how it was resolved (e.g., cruise terminated, MPD/Harbor Patrol contacted). These logs shall be made available to representatives of the MPD or ABRA on request. Licensee shall to the full extent permissible by law discourage loitering in the vicinity of the marine vessels and docks. While the ANC does not at this time envision any requirement for security officers at the time of the cruises, as indicated above, the Licensee shall ensure that there is no post-cruise activity continuing on the docks and any persons who are congregating in that manner shall be asked to move along. At the present time, the ANC does not envision the need for electronic devices to search for weapons, pat-downs of patrons when coming on board, or cameras or devices to record and store information about activities on the exterior of the marine vessels.

Licensee shall post signs at the exits of each of the marine vessels to inform patrons that no alcoholic beverages can be removed from any of the licensed vessels. Licensee shall ensure that no containers, cups, bottles/cans, etc. regardless of content, shall be permitted to exit any of the marine vessels with a patron, and shall ensure that no alcoholic beverages are carried out of any of the marine vessels so that they can be consumed on public space or in a vehicle.

9. License Ownership and Compliance with ABRA Regulations. Licensee promises that it shall abide by all Alcoholic Beverage Regulations Administration (ABRA) regulations regarding the ownership of the license and all other provisions applicable to liquor licensees, and agrees that the ANC shall have standing to ask the ABC Board to enforce any violations of

the agreement.

- 10. **Participation in the Community.** Licensee agrees to seek to maintain open communication with the community for which the ANC acts.
- 11. Notice and Opportunity to Cure. In the event that any of the parties is in breach of this Agreement, it shall be entitled to reasonable notice and opportunity to cure, as a condition precedent to seeking enforcement of the Agreement. Unless the breach is of an emergency nature or is a repetition of a prior breach, reasonable notice and opportunity shall provide for a cure within 30 days of the date of such notice. If Licensee fails to cure within the 30-day period (or, with respect to a breach which reasonably requires more than 30-days to cure, fails to commence cure of such breach which reasonably regires more than 30 days to cure) failure shall constitute a cause for the ANC to file a complaint with the ABC Board pursuant to D.C. Official Code § 25-446(2) in order to enforce the provisions of the Agreement. Unless otherwise noted above, any notices required to be made under this Agreement shall be in writing and mailed via certified mail, return receipt requested, postage prepaid, or hand-delivered, to the other parties to this Agreement at the following addresses. Notice shall be deemed given as of the time of receipt or refusal of receipt:
