1 P R O C E E D I N G S

2 CHAIRPERSON ANDERSON: All right. The next
3 case on our show cause hearing status is Case Number
4 15-251-00176, The Shadow Room, License Number 75871.
5 Will the parties please approach.

6 MR. RIVERO: Good morning, Board Members.
7 Fernando Rivero for the District of Columbia.

8 CHAIRPERSON ANDERSON: And the licensee is
9 not here.

10 MR. RIVERO: I'm actually not sure since I
11 did have a conversation with the licensee about this
12 case. I do know that we do not have an Offer in
13 Compromise to present to The Board at this time, and
14 we'll move forward to the next scheduled hearing.

15 CHAIRPERSON ANDERSON: And just -- just a
16 quick -- they were also -- were they -- are you -- do
17 you know whether or not they were served for this?

18 MR. RIVERO: Oh, yes.

19 CHAIRPERSON ANDERSON: Yes.

20 MR. RIVERO: Oh, yes.

21 CHAIRPERSON ANDERSON: All right. Okay.

22 All right. This matter is then scheduled for a show

1 cause hearing on May 18th at 1:30 p.m. Thank you.

2 (Whereupon, the above-entitled matter was
3 recalled.)

4 CHAIRPERSON ANDERSON: I'm going to recall
5 then Case Number 15 -251-0176, The Shadow Room, License
6 Number 75871. Will the parties please approach and
7 identify themselves for the record.

8 MR. RIVERO: Good morning, Board Members.
9 Fernando Rivero for the District of Columbia. Swaptak
10 Das for Acott Ventures. S-W-A-P-T-A-K, last name is
11 Das, D-A-S.

12 CHAIRPERSON ANDERSON: Thank you. All
13 right. Hold on. And who are you, Mr. Das?

14 MR. DAS: I'm one of the owners of the
15 establishment.

16 CHAIRPERSON ANDERSON: Okay. All right.
17 All right. Are there any preliminary matters in this
18 case?

19 MR. RIVERO: There aren't. The Government
20 doesn't mind recalling the case because I understand the
21 licensee was in traffic for quite some time.

22 MR. DAS: I -- I left at 7:45. I was on the

1 14th Street Bridge.

2 CHAIRPERSON ANDERSON: We are -- we are
3 aware of the -- the traffic this morning. So I --

4 MR. RIVERO: So the parties don't have an
5 offer in compromise to present at this time. But we are
6 discussing a possible settlement of the matter. And if
7 that happens and it's appropriate, we will request an
8 additional status hearing to present that.

9 CHAIRPERSON ANDERSON: All right. All
10 right. Currently this case is scheduled for a -- a show
11 cause hearing on -- on May 18th at 1:30. And so
12 depending on what happens the parties can let us know
13 whether or not -- what is going to happen -- whether or
14 not you're going to move forward with the hearing May
15 18th at 1:30. Okay.

16 MR. RIVERO: Thank you.

17 MR. DAS: Again, I apologize for being late.

18 CHAIRPERSON ANDERSON: Your apology is
19 accepted, and I'm speaking for the -- we are aware of
20 traffic this morning. So you're fine. That's one of
21 the reasons why I recalled the case because we are aware
22 and you did show up. So that's fine.

1 MR. DAS: Thank you, sir.

2 CHAIRPERSON ANDERSON: All right. Thank
3 you. Thank you, Mr. Rivero.
