2 CHAIRPERSON ANDERSON: All right. The
3 next case on our show cause hearing status is
4 Case No. 15-CMP-00795 STK, License No. 92844.
5 Will the parties please approach?

6 MS. PHILLIPS: Louis Phillips, Assistant
7 Attorney General for the District of Columbia.

8 CHAIRPERSON ANDERSON: And the licensee
9 is not here. Is this your case, Ms. Phillips?

10 MS. PHILLIPS: It is not.
