3 CHAIRPERSON ANDERSON: The second case  
4 on our calendar, another Protest (Status) Case,  
5 Case No. 18-PRO-00027, S & G Wine & Liquors,  
6 License No. 93800.

7 Will the parties, please, approach and  
8 identify themselves for the record, please?

9 MR. DIETZ: Good morning. I'm Bernard  
10 C. Dietz for the applicant.

11 CHAIRPERSON ANDERSON: Good morning,  
12 Mr. Dietz.

13 MS. ROTH: How are you? My name is  
14 Nancy Roth and I'm with ANC-4D01.

15 CHAIRPERSON ANDERSON: Good morning,  
16 Ms. Roth.

17 All right. Are there any preliminary  
18 matters to be addressed?

19 MR. DIETZ: Yes. My client is  
20 prepared to sign a voluntary agreement. She is  
21 not here yet, but she is on her way here. The  
22 agreement is ready to be signed and we will

1 submit it to the Board for approval.

2 CHAIRPERSON ANDERSON: And does the  
3 ANC need -- I'm sorry, does the --

4 MS. ROTH: This is an agreement, sir,  
5 that we are trying to --

6 CHAIRPERSON ANDERSON: No. I'm asking  
7 a different question. I'm saying has it been  
8 already ratified by the entire ANC?

9 MS. ROTH: Oh, yes, sir.

10 CHAIRPERSON ANDERSON: No, the reason  
11 I'm asking is because this matter is scheduled --  
12 all right. So this matter is scheduled for a  
13 Show Cause Hearing on June -- I'm sorry, for a  
14 Protest Hearing on July 18th at 4:30.

15 And if the parties, if as you said,  
16 you are ready to sign an agreement, you sign the  
17 agreement, send it to the Board and we will  
18 cancel the hearing. So I don't need to --  
19 normally, I would review the terms about a  
20 Protest Hearing and what would go on, but since  
21 the folks tell me that they are going to sign a  
22 settlement agreement, I guess I won't see you on

1 July 18th.

2 And I always tell the parties that I  
3 prefer when you sign agreements, because at least  
4 you set the terms of the establishment in your  
5 neighborhood and you don't have it left to us to  
6 make a decision. So I won't see you on July 18th  
7 and I won't take it personal. And good luck with  
8 your -- good luck. Sign on the agreement and  
9 send it to the Board and we will review it and if  
10 there is any problem, we will make some minor  
11 changes, but thank you. Have a great day.

12 MS. ROTH: Thank you. Do I need to  
13 sign this?

14 CHAIRPERSON ANDERSON: Yes, please.

15 MS. ROTH: Okay.

16 CHAIRPERSON ANDERSON: Yes.
