**ORDER TO CEASE AND DESIST**

The Alcoholic Beverage Regulation Administration (ABRA) has reviewed its records and determined that Kelly's Michigan Park, LLC, t/a San Antonio Bar & Grill III located at 3908 12<sup>th</sup> Street, N.E., Washington, D.C., has failed to renew License No. ABRA-079523, a Retailer's Class CT License. Specifically, you failed to renew your license by September 30, 2010, the deadline for all Retailer's Class CT licenses, despite being notified of the renewal date. Therefore, your license has **EXPIRED** until you pay the renewal fee and the \$50.00 per day fine imposed by the Alcoholic Beverage Control Board (Board) for late payment.

Pursuant to D.C. Official Code § 25-829 you are therefore **ORDERED** by the Board on this 20th day of October, 2010, to **STOP selling, serving, or permitting the consumption of alcoholic beverages at your establishment** until payment of the renewal fee and any associated fines are received by ABRA.
