ORDER ON DISMISSAL OF PROTEST

The Application filed by The Stadium Group, LLC, Inc., t/a Stadium (Applicant) for renewal of its Retailer's Class CN License, having been protested, came before the Alcoholic Beverage Regulation Administration (ABRA) for a Status Hearing on July 14, 2010, in accordance with D.C. Official Code § 25-601 (2001).

On July 14, 2010, pursuant to Title 23 of the District of Columbia Municipal Regulations ("23 DCMR") § 1602.3 (2004), the Alcoholic Beverage Control Board (Board) dismissed the Henderson Group of Five for failure to appear at the Status Hearing. The Henderson Group of Five may file a Request for Reinstatement with the Board within ten (10) days from the date of this Order. The Padou Group of Five remains a Protestant in this matter.


ORDER






