**ORDER GRANTING GOVERNMENT'S MOTION TO DISMISS**

This matter comes before the Alcoholic Beverage Control Board (Board) as a Show Cause Status Hearing in Case No. 14-CMP-00737 against Taste International, Inc., t/a Taste (Respondent).

At the Show Cause Status Hearing, the District of Columbia (Government) moved the Board to dismiss the case because it has determined that on February 13, 2015, the Respondent's license was transferred to TMI International, Inc., t/a Sip. The Respondent's License No. ABRA-086011 is no longer operational. The establishment, located at 1812 Hamlin Street, N.E., Washington, D.C., is operating under TMI International, Inc.'s License No. ABRA-095164, and is not the entity that incurred the charges set forth in the Government's Notice to Show Cause dated December 2, 2015.

For these reasons, on this 20<sup>th</sup> day of January, 2016, the Board hereby **GRANTS** the Government's Motion and **DISMISSES** Case No. 14-CMP-00737 against the Respondent. A copy of this Order shall be sent to the Respondent and the Government.

Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14<sup>th</sup> Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
