ORDER GRANTING APPLICANT'S REQUEST FOR REINSTATEMENT

The Application filed by The Juniper Group, LLC, t/a The Blaguard, for renewal of its Retailer's Class CR License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on September 9, 2013, in accordance with D.C. Official Code § 25-601 (2001).

On September 9, 2013, the Board dismissed the Application, because the Applicant failed to appear at the Roll Call Hearing. *See* Board Order No. 2013-403.

On September 11, 2013, Nicolas Makris, on behalf of the Applicant, filed a request for reinstatement indicating that he failed to attend the Roll Call Hearing, because a car trouble and he could not notify the Board Agent of his inability to attend the Roll Call Hearing after the hearing had concluded.

ABRA records show that after the Roll Call Hearing, Mr. Makris informed the Board Agent that a car trouble prevented him from appearing for the hearing.
