
Accordingly, it is this 2nd day of June 2010, **ORDERED** that:






**AMENDMENT TO COOPERATIVE AGREEMENT CONCERNING
SUBSTANTIAL CHANGE (ENTERTAINMENT ENDORSEMENT)
TO LICENSE FOR SALE OF ALCOHOLIC BEVERAGES**

On this 1st day of July, 2009, PERCULUS, INC., T/A THE REEF, 2442-46 18th Street, NW, CT-02 license number 29524, Advisory Neighborhood Commission 1C (ANC 1C) and the Kalorama Citizens Association (KCA), being parties to a Cooperative Agreement executed December 13, 2005, do hereby agree to amend that agreement as follows:

1. Applicant agrees to submit an application to the Board containing a request for only the Entertainment Endorsement elements described in this amendment. The parties understand that public notice must be given through placarding of this request.
2. The Applicant may construct a DJ booth in the front south corner of the 2nd floor dining room. Seating removed for this construction shall be replaced in another location in the same dining room so that the number of seats and tables remains the same.
3. The Applicant may feature a DJ or Karaoke beginning no earlier than 10:00 pm. Applicant shall ensure that the DJ or Karaoke operation does not interfere with the service of food during times designated elsewhere in this agreement as hours for the service of dinner. See section 1. A.) (2).
4. Dancing shall be allowed during times that the DJ is providing music. Applicant agrees to not promote dancing through any means of advertising, whether in print or electronic media. There shall be no designated dance floor.

Upon approval of these amendments by the Board in an Order, the Parties request that this page, numbered 6, be attached to the aforementioned Cooperative Agreement.


