3 AGENT FLETCHER: This is Case number
4 18-PRO-00063. Thank you. And you can actually
5 have a chair right there. Thank you. I think
6 the other party is coming now. Thank you.

7 I was wrong about that. I'll proceed.
8 Thank you. This is Alley Bar, LLC, trading as
9 The Little Grand, 808 7th Street NE, License
10 number ABRA-110495, Retailer Class CT new
11 application.

12 The protest issues are adverse impact
13 on peace, order, and quiet, residential parking,
14 and vehicular and pedestrian safety, and real
15 property values.

16 My name is LaVerne Fletcher. I'm
17 conducting the Roll Call Hearing as the Board's
18 Agent. Introductions, beginning with the
19 applicant, please. Your name, sir? If you could
20 state it and spell it for the record.

21 MR. BATISTA: My name is David
22 Batista. It's D-A-V-I-D, B-A-T-I-S-T-A.

1 AGENT FLETCHER: Mr. Batista, are you
2 the owner?

3 MR. BATISTA: Yes.

4 AGENT FLETCHER: Thank you very much.
5 Is anyone present on behalf of ANC 6C? Mr.
6 Batista, have you had any communication with ANC
7 6C?

8 MR. BATISTA: Yes.

9 AGENT FLETCHER: You are, is there a
10 settlement agreement?

11 MR. BATISTA: There is not.

12 AGENT FLETCHER: Okay. Thank you very
13 much. The time is approximately 10:10 a.m. ANC
14 6C is not present. The protest is dismissed
15 because they are not present at this time.

16 What that means is, they will get a
17 Board Order dismissing the protest. Mr. Batista,
18 did you put your contact information on that
19 sheet?

20 MR. BATISTA: Yes.

21 AGENT FLETCHER: Okay. Thank you.
22 You're going to receive a copy of the Board Order

1 dismissing them as a protestant. The ANC will
2 have ten days to seek reinstatement of the
3 protest.

4 If the Board reinstates the protest,
5 then you'll hear from me. I'm LaVerne Fletcher.
6 That's my card on the table. If they reinstate
7 the protest you'll hear from me. Because I will
8 need to schedule a date a mediation, a status
9 hearing, and a protest hearing.

10 MR. BATISTA: Okay.

11 AGENT FLETCHER: You'll be kept
12 informed beyond today of what happens, using the
13 contact information that you provided today. Any
14 questions at all?

15 MR. BATISTA: No.

16 AGENT FLETCHER: Okay. Thank you very
17 much for coming. The Roll Call Hearing is
18 concluded. Thank you.
