ORDER TO CEASE AND DESIST

The Alcoholic Beverage Control Board (Board) has been notified by the Department of Consumer and Regulatory Affairs (DCRA), Corporations Division, that Beg Investments, LLC, t/a Twelve Restaurant & Lounge's (Licensee), at premises 1123-1125 H Street, N.E., Washington, D.C., Certificate and registration document were revoked on September 16, 2013, pursuant to the District of Columbia Business Organizations Code. In accordance with the laws and regulations of the District of Columbia, the Licensee shall not engage in the sale or service of alcoholic beverages unless its corporation is in good standing.

Pursuant to D.C. Official Code § 25-829 you are therefore **ORDERED** by the Board on this 7th day of May, 2014, to **STOP selling, serving, or permitting the consumption of alcoholic beverages under your Retailer's Class CT License No. ABRA-076366**. You may not allow the sale of alcoholic beverages until your ABC License is reinstated by the Board.


