ORDER ON DISMISSAL OF PROTESTS

The Application filed by Eun & Peter, Inc., t/a Uncle Lee's Seafood, for a new Retailer's Class A License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on January 24, 2011, in accordance with D.C. Official Code § 25-601 (2001).

On January 24, 2011, pursuant to Title 23 of the District of Columbia Municipal Regulations ("23 DCMR") § 1602.3 (2004), the Board dismissed the Protests of Alice Bush, Vernessa L. Dickens, and The Eastern Plaza Condominium Association, because



ORDER


