2 ROLL CALL HEARING

3 CHAIRPERSON FLETCHER: Will the parties  
4 in the case of Village Whiskey please come  
5 forward? The parties in the matter of Village  
6 Whiskey. This is Case #16-PRO-00025, GRGDC3,  
7 L.L.C., trading as Village Whiskey, 920 N Street  
8 Northwest, license ABRA-0102077. This is  
9 Retailer class CR. It's a new application. The  
10 protest issues are adverse impact on peace, order  
11 and quiet and real property values. My name is  
12 Laverne Fletcher and I'm conducting the Roll Call  
13 Hearing as the Board's Agent pursuant to D.C.  
14 Official Code 1601.2 Introductions beginning  
15 with the applicant.

16 MR. FONSECA: Michael Fonseca on behalf  
17 of the licensee.

18 MR. KEDDIE: Rob Keddie, R-O-B, K-E-D-D-  
19 I-E, on behalf of the licensee.

20 CHAIRPERSON FLETCHER: Rob, what was your  
21 last name again?

22 MR. KEDDIE: Keddie, K-E-D-D-I-E.

1 CHAIRPERSON FLETCHER: D-D-I-E. Mr.  
2 Fonseca would you spell your name for the record?

3 MR. FONSECA: I provided the court  
4 reporter with my card.

5 CHAIRPERSON FLETCHER: Thank you.

6 MR. FONSECA: You're welcome.

7 CHAIRPERSON FLETCHER: Present on behalf  
8 of ANC 2S?

9 MR. BENDEL: Good morning, Commissioner  
10 Charlie Bendel, SMD 2f06, last name is Bendel, B  
11 as in boy B-E-N-G-E-L.

12 CHAIRPERSON FLETCHER: B-E-N-G-E-L?

13 MR. BENDEL: Yes.

14 CHAIRPERSON FLETCHER: Charlie, C-H-A-R-  
15 L-I-E?

16 MR. BENDEL: Yes.

17 CHAIRPERSON FLETCHER: ANC 2F does have  
18 standing as a protestant. We need to set a date  
19 for a Status Hearing, a Protest Hearing and a  
20 Mediation. The date of the status hearing is  
21 June 8th at 9:30. The date of the Protest  
22 Hearing is July 13th at 1:30.

1 MR. BENGEL: If we could try to have the  
2 Mediation as close to the Status Hearing as  
3 possible because we think this issue will be  
4 resolved prior.

5 CHAIRPERSON FLETCHER: Okay.

6 MR. FONSECA: It's a singular issue over  
7 an hour that requires some time to satisfy the  
8 ANC commissioners.

9 CHAIRPERSON FLETCHER: Okay. In that  
10 case, is June 7th too close?

11 MR. BENGEL: That's fine with me.

12 MR. FONSECA: That's fine. Mr. Keddie  
13 has to come from Philadelphia, so if we can have  
14 an afternoon maybe 2:00pm.

15 MR. BENGEL: Sure.

16 CHAIRPERSON FLETCHER: What time, Mr.  
17 Fonseca?

18 MR. FONSECA: Do you have a 2:00 p.m.?

19 CHAIRPERSON FLETCHER: Yes.

20 MR. FONSECA: That's fine.

21 CHAIRPERSON FLETCHER: The mediation is  
22 set for Tuesday, June 7, at 2:00 p.m. and I'll

1 make a note that it may not be necessary, it's  
2 just on the book for the record, but you can let  
3 me know.

4 MR. FONSECA: I'll definitely let you  
5 know --

6 CHAIRPERSON FLETCHER: I know you will.

7 MR. FONSECA: -- if we're able to resolve  
8 this before then.

9 CHAIRPERSON FLETCHER: Do you have any  
10 questions at all? Mr. Bengel did you share your
