**ORDER DENYING REINSTATEMENT**

The Application filed by American Arab Communication & Translation Center, LLC, t/a Zenobia Lounge, for a new Retailer's Class CR License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on September 20, 2010, in accordance with D.C. Official Code § 25-601 (2001).


On September 20, 2010, pursuant to Title 23 of the District of Columbia Municipal Regulations ("23 DCMR") § 1602.3 (2004), the Board dismissed the Protest because the Protestant failed to appear at the Roll Call Hearing. On September 27, 2010, Protestant requested reinstatement because a misreading of the schedule on the part of Protestant led to their inadvertent failure to appear at the Roll Call Hearing.

Upon consideration of the request, the Board does not find good cause to reinstate Protestant pursuant to 23 D.C.M.R. 1602.3.


Accordingly, it is this 6<sup>th</sup> day of October 2010, **ORDERED** that:


1. The Request for Reinstatement of the Protest filed by ANC 2E, is **DENIED**; and




