Accordingly, it is this 10th day of April, 2013, **ORDERED** that:



SETTLEMENT AGREEMENT AND AMENDMENT TO VOLUNTARY AGREEMENT

THIS SETTLEMENT AGREEMENT AND AMENDMENT TO VOLUNTARY AGREEMENT is made on this 11 day of March 2013 by and between C.J. Enterprises, LTD. t/a Ziegfields/Secrets License No. ABRA-001368 (Licensee or Applicant), and Advisory Neighborhood Commission 6D (ANC 6D)

RECITALS

WHEREAS, Licensee and ANC 6D entered into a Voluntary Agreement dated April 9, 2008, concerning the Licensee's Retailer's Class CN alcoholic beverage license for an establishment located at 1824 Half Street, SW, Washington, D.C.; and

WHEREAS, in the original Voluntary Agreement, ANC 6D requested and Licensee agreed to specific controls regarding the Hours of Operation and Sales of Alcoholic Beverages; and

WHEREAS, the Parties have agreed to enter into this Settlement Agreement and Amendment to Voluntary Agreement to permit the Licensee to amend its Hours of Operation and Sales of Alcoholic Beverages for otherwise legally permissible exceptions as set forth more clearly below; and

WHEREAS, the Parties request that the Alcoholic Beverage Control Board approve this Settlement Agreement and Amendment to Voluntary Agreement conditioned upon the Licensee's compliance with the terms of this written Amendment and the previously executed Voluntary Agreement; and

NOW, THEREFORE, in consideration of the recitals set forth above, it is mutually understood and agreed by and between the undersigned Parties to amend the previously executed Voluntary Agreement as follows:

1. ***Recitals Incorporated.*** The recitals set forth above are incorporated herein by reference.
2. ***Hours of Operation and Sales.***

The Parties Agree to Amend the Voluntary Agreement by substitution of a new Section 3 as follows:

3. Hours of Operation and hours for sales, service and consumption of alcoholic beverages


Sunday:	3:00 p.m. - 2:00 a.m.
Monday through Thursday	9:00 p.m. - 2:00 a.m.
Friday and Saturday:	9:00 p.m. - 3:00 a.m.


Provided, however, (1) on days designated by the DC ABC Board as "Extended Hours for ABC Establishments" Applicant may serve alcoholic beverages and provide entertainment for one additional hour (that is, one hour later in the morning); (2) in the event the Council of the District of Columbia or the DC ABC Board grant licensees in general extended operating hours Applicant may avail itself of such extended hours; and (3) on January 1 of each year Applicant may serve alcoholic beverages and provide entertainment until 4am.



At its regularly scheduled and properly noticed business meeting on November 12, 2012, at which a quorum was present (a quorum being four of our seven Commissioners), ANC-6D voted 5 to 0 to 1 to support amending the existing Voluntary Agreement for Ziegfield's/Secrets to remain open on Mondays with the same hours of operation and alcohol sales as exist in the present VA and in the ABC license as for Tuesday through Sunday operations.

ANC-6D hopes that this letter will be sufficient to ensure that this change is made in time for the operator to serve the public this New Year's Eve, as it occurs on a Monday. The unamended VA, for some reason, does not include Monday hours of operation.







VOLUNTARY AGREEMENT

AGREEMENT made this 9th day of April 2008, by and between C.J. Enterprises, Ltd. T/A Ziegfeld's/Secrets (the applicant) and Advisory Neighborhood Commission 6D (the ANC).

WHEREAS, Protestant is the Advisory Neighborhood Commission 6D which filed a timely protest against the issuance of the Applicant's license application pursuant to D.C. Official Code 25-601(1) and 601(4) respectively;

WHEREAS, Ziegfeld's/Secrets has petitioned the District of Columbia Alcoholic Beverage Control Board (the ABC Board) to transfer the nightclub from safekeeping to a new location and issue a Liquor License; and

WHEREAS, the premises, 1824 Half Street SW, is within the boundaries of the ANC; and,

WHEREAS, the parties desire to enter into an agreement detailing certain understandings regarding the Applicant's operating plans, and request that the Alcoholic Beverage Control Board (ABC Board) approve the Applicant's license application conditioned upon the Applicant's compliance with the terms of this written Agreement; and

WHEREAS, the parties are desirous of entering into a Voluntary Agreement pursuant to D.C. Official Code 25-446 for the operation and maintenance of the establishment in such a manner as to minimize the effect on (1) peace, order, and quiet of the neighborhood, and (2) pedestrian safety and vehicular traffic, and to eliminate the need for a Protest Hearing regarding the license application.

NOW, THEREFORE, in accordance with the recitals set forth above and the mutual covenants and conditions set forth below, the parties agree as follows:

1. **Recitals Incorporated.** The recitals set forth above are incorporated herein by reference.
2. **Nature of the Business.** The applicant will manage and operate a nightclub which will feature nude dancing; disk jockeys; live music such as reggae, salsa, rhythm and blues, soul, latin, go-go; and dancing by patrons.
3. **Hours of Operation and Sales.** The applicant's hours of operation and sale of liquor shall be as follows:
Sunday, 3 p.m. to 2 a.m. Monday;
Monday closed;
Tuesday through Thursday, 9 p.m. to 2 a.m.; and
Friday and Saturday, 9 p.m. to 3 a.m.
4. **Floors Utilized and Occupancy.** The applicant will operate its establishment on two (2) floor(s) of the building. The establishment will have no more than 250 seats and the maximum occupancy of the establishment shall not exceed 599 patrons.
5. **Parking.** A concern of the protestants is that the applicant's operation of the establishment does not create or exacerbate parking problems within the ANC boundaries. As discussed in section 11 below, applicant will maintain open communication with the immediate neighborhood resident councils to discuss and alleviate any parking concerns.
6. **Noise and Privacy.** Applicant will strictly comply with D.C. Official Code 25-725 and to that end shall ensure that music, noise, and vibration from the establishment are not audible in the nearby residential properties. Applicant agrees to keep its doors and windows closed when live music is being played at

the establishment. If necessary, applicant will take reasonable steps to reduce noise emanating from the establishment from the opening of the entry or exit doors.

7. **Public Space and Trash.** Applicant will take reasonable measures to ensure that the immediate environs of the premises are kept free of litter and debris. "Immediate environs" is defined in paragraph 720.2 of the ABC Regulations as including: "all property on which the premises are located; all property used by the licensee to conduct its business, whether part of the premises or not, including parking lots and the portion of alleys, sidewalks, or other public property immediately adjacent to the premises or adjacent to the property used by the licensee to conduct its business. Applicant will seek to ensure that all litter, including flyers and illegal posters attached to lampposts, trees, and edifices, is removed. Applicant is required to have appropriate and sufficient staff for the purpose of enforcing this litter and cleanliness requirement.
8. **Rats and Vermin Control.** The applicant shall provide rat and vermin control for environs of the property. Applicant shall have the establishment and the area around the premises properly cleaned at the end of each night to ensure that there are not garbage and odors present the following morning.
9. **Security Cooperation and efforts to Stem Illegal Drugs and Public Drinking.** Protestants are concerned that the number of potential occupants of the premises will pose security and crime issues. Applicant agrees that it shall take all necessary steps to minimize such problems, including designating a sufficient number of employees to assure adequate security and to control unruly patrons, whether inside or in the immediate outside area; monitoring for and prohibiting sales or use of illegal drugs within or about the premises, and maintaining contact and cooperating with MPD and other enforcement officials when known or suspected drug activities occur. Applicant shall to the full extent permissible by law discourage loitering in the vicinity of the premises. This will include providing an appropriate number of security officers at all times when the establishment is open to the public who shall be responsible for ensuring that any individuals who are simply loitering are asked to move along. The Applicant will train appropriate staff on procedures for evacuating patrons and removing chairs, barricades and other obstacles in the event that a fire, medical or other emergency requires that the area be accessible to EMS or Police. Signage encouraging safe drinking and driving will be visibly posted in areas of service and exits of the establishment. Applicant will maintain a "cool down" area for patrons prior to allowing patrons who, based on the judgment of the applicant and his staff, are not in condition to exit the establishment to the neighborhood or to drive. Applicant will offer patrons the opportunity to take a breathalyzer test prior to exiting the premises. Furthermore, the applicant will publicly post signs advising its customers and patrons of the need to maintain quiet when exiting the club and residential area and not to loiter outside the club. Such signage will contain maps directing patrons to exit the area via Half Street to Potomac Avenue to South Capitol Street.
10. **License Ownership and Compliance with ABRA Regulations.** Applicant promises to protestants that it shall abide by all Alcoholic Beverage Regulations Administration (ABRA) regulations regarding the ownership of the license and all other provisions applicable to liquor licensees, and agrees that protestants shall have standing to ask the ABC Board to enforce any violations of the agreement. Applicant also specifically agrees to be the sole owner of the ABC license. The applicant will ensure that all alcoholic beverage sales staff has appropriate training in the sale and handling of alcoholic beverages. The applicant will also ensure that the ABC Board-approved manager has received training of the type offered by TIPS. The applicant also agrees to refuse service to any person who is intoxicated or is in danger of becoming intoxicated.
11. **Participation in the Community.** Applicant agrees to seek to maintain open communication with the protestants, the community for which the ANC acts, and especially the immediate neighborhood. To this end, applicant shall from time to time be represented at ANC6D public meetings which currently occur on the second Monday of each month (except August when there is no meeting, and October

when the meeting is on the third Monday) at 7 p.m. at St. Augustine's Episcopal Church, 6th and M Streets, S.W., Washington, D. C. 20024. Applicant, upon notice from the ANC shall send a representative of the establishment to a meeting (s) to confer and deal in good faith with Issues raised under this Agreement. In addition, applicant is encouraged to participate in the local business community, the meetings of PSA 104, and residential councils to discuss parking issues, responsible alcohol service, law enforcement activities, clean streets and sidewalks, loitering, and to support neighborhood charitable and social events. The applicant will advertise employment opportunities to members of the community whenever they may become available.

If any arrest occurs either within the establishment, or of patrons coming immediately from the establishment, the Applicant will inform the ANC within a 24 hour period of any such arrest(s) that they are made aware of.

The Applicant will notify the ANC of any significant change in the manner of operations at least 30 days in advance.

The Applicant agrees to implement the following policies in order to establish a relationship with the community to promote peace, order and quiet.

- a. All managers and staff will receive training to ensure that local residents have immediate access to a manager on duty to report problems or lodge complaints.
- b. The Applicant will keep a log of all complaints and provide copies to the ANC.
- c. At the request of five or more local residents, the ANC, or the Commissioner for the SMD, the Applicant agrees to hold up to four public meetings per year within 15 days of such a request to hear and respond to community concerns.

The Applicant will, at the request of any individual or group located in ANC6D, maintain a notification list to inform the community of planned events

12. **Notice and Opportunity to Cure.** In the event that any of the parties is in breach of this agreement, it shall be entitled to reasonable notice and opportunity to cure, as a condition precedent to seeking enforcement of the agreement. Unless the breach is of an emergency nature or is a repetition of a prior breach, reasonable notice and opportunity shall provide for a cure within 30 days of the date of such notice. If applicant or the licensee fails to cure within the 30-day period (or, with respect to a breach which reasonably requires more than 30 days to cure, fails to commence cure of such breach and diligently pursues such cure) failure shall constitute a cause for seeking a Show Cause Order from the ABC Board pursuant to D. C. Official Code paragraph 25-447. Unless otherwise noted above, any notices required to be made under this agreement shall be in writing and mailed via certified mail, return receipt requested, postage prepaid, or hand-delivered, to the other parties to this Agreement at the following addresses. 


